

WHO IS COFI?

The Association:

The Council of Forest Industries is the voice of the BC interior forest industry. COFI member companies operate 100 production facilities in more than 60 forest dependent communities in the interior of British Columbia. COFI member company operations account for approximately 80 percent of all BC softwood lumber shipments and about 35 percent of Canadian softwood lumber shipments.

COFI member companies employ approximately 50,000 people directly. About 150,000 families directly and indirectly depend on COFI member companies for their livelihood and well-being.

The COFI Annual Convention

The convention is the largest gathering of the forest industry in Western Canada and attracts forest industry CEOs and their senior management and production teams from continental North America and offshore, senior representatives from customers, suppliers, financial institutions, law firms, local government, chambers of commerce, Federal & Provincial Ministers, MPs, MLAs and senior civil servants.

The convention alternates between Prince George, BC and Kelowna, BC. At the 2007 Annual Convention in Prince George, President & CEO, John Allan announced that part of the proceeds from the success of the annual convention would go towards introducing these ten \$1000.00 Entry Level Scholarships to be awarded to students enrolled in profession technical or trades studies at one of the ten BC Interior Colleges or Universities, leading to a career in the Forest Industry.

1. Transcript Record

A copy of your most recent Transcript from High School or College. Please advise us if they are delayed for any reason.

2. Letters of Reference

A letter of reference from your principal, program instructor, or classroom teacher, a community reference, or employer who is not related to you.

3. Written Letter

A brief letter outlining your educational and career goals and why you should be considered for scholarship funding.

4. Photograph

If awarded the scholarship, a recent photo would be required along with permission to publish in the Corporate Newsletter.
